Summer Online Courses:

Online courses will work slightly different from our on campus courses. Grace Summer Online provides the same quality educational experience in a shorter time frame, which requires focused learning that must be completed by the given deadlines within the 10-week course period. Each student should prayerfully consider taking an online course as preparation for their future educational experiences.

By going to the Grace Academy website and accessing Moodle, students are able to view the assignments and grades, take tests, download video clips of lessons and communicate with the instructor online. Students who participate in the Grace Online Learning Program experience the benefit of completing assignments on their own schedule with carefully guided assignments and in the environment of their choice; all it takes is an internet connection!

Online Tuition:

Summer Online Course Tuition is \$1,050 per course (Exception: All math courses are \$2,090 per course, except Consumer Math.) The cost of all textbooks/workbooks are the responsibility of the parent/student and are not included in tuition.

Online Administrative Fee:

Online Application Fee is \$150 per year. If you are registered for the current year at Grace Academy, the online application fee does not apply. If you have taken an online course in the past, the online application fee is waived. The online administrative fee is non-refundable.

Summer Online 2024 Courses are to be paid in full at the time of registration and are Non-Refundable at any time and Non-Transferable to any other course, session, siblings or any other student. A Summer Online Course must be dropped by Tuesday, June 4, 2024. Dropping a course after the June 4, 2024 deadline will result in an F on the student transcript.

If your student is not a Grace Academy Student, it is the discretion of the School in which your child attends to accept this course as a transfer credit. Additionally, Grace Academy is not responsible for any verification of the acceptance of this course by the school in which your child is attending.
